Overnight parking on the streets in our Ward has become a serious problem.

There are streets, where, if there was an emergency, first responders' vehicles would not be able to pass.

As winter approaches, we will soon be thinking about having to get our streets ploughed. I have been asked by City Staff if I would consider having no overnight parking in our Ward as a pilot project in order to make sure our streets can be ploughed effectively.

The Heathwood subdivision in our community presently has no overnight parking from 2am to 6 am.

There is consideration for no overnight street parking in our Ward from 2 am to 6 am.
